1. THE WHOLE PAPER

First, say something positive about your partner's argument. What is **done well**?

Overall, does the **general direction** of the paper make sense? Does it leave you with any **unanswered questions**? If so, where? What does it need to be improved?

2. INTRODUCTION

Examine the **thesis**. Does it follow the needed format? Is each of the **supporting arguments** debatable? Does it need improvement? How?

3. DEVELOPMENT and USE of SUPPORTING EVIDENCE

Do the **evidence** and **analysis** back up the claim for each paragraph? How could they be stronger (e.g., more evidence needed, re-arrange the elements, etc.)?

Does the **analysis explain the evidence** well and show its importance for the argument? Why, or why not?

In the **final body paragraph**, does the author present one or more **counter-claims** (opposing arguments)? How appropriate is the objection? How effective is the response?

Look at the paper's use of **in-text citations**. Is **every single fact** cited appropriately? Make sure to point out places that need improvement to help your partner avoid plagiarism.

4. CONCLUSION

Does the conclusion demonstrate **the importance or the implications of the solution** for the wider world? What kind of **impact** does it leave on the reader?
